- There are two proposals submitted for consideration at the AGM
- (i) Annual Membership Fee proposal

"The Annual Membership Fee for new members from 1 December 2020 will increase to £50. Existing members who have paid their membership fee for year ended 30 September 2020 will be considered as having also paid their fee for the year ended 30 September 2021. In other words, in recognition of the disruption caused by Covid-19, these members will have 2 years membership for the price of one. The England Athletics fee of £15 will remain payable in the normal way."

(ii) Change to constitution due to name change of stadium

RULE 1

The name of the Club shall be Shaftesbury Barnet Harriers, hereinafter called the Club whose headquarters are at The Clubhouse, Barnet Copthall Stadium Allianz Park, Greenlands Lane, Hendon, London, NW4 1RL
