NOTES

- (1) Fixed Assets Clubhouse The cost of the Clubhouse of £63,122 has been reduced by £52,122 being the balance on the Headquarters Fund representing the monies specifically fund-raised for this purpose. The Clubhouse is subject to a lease from Saracens for 15 years from 12/03/13 with an option to extend a further 15 years to 11/03/43. The net cost of £11,000 paid from club reserves will be amortised over the remaining 20 years at an annual rate of £550.
- (2) Fixed Assets Floodlights SBH received a grant from the London Marathon Charitable Trust £45,650 to upgrade the Floodlights at Barnet Copthall Stadium. With the consent of the LMCT, these funds were passed over to Saracens in 2011as a contribution towards the cost of the new Floodlights installed at the Stadium.
